1. Call To Order And Roll Call:

2. Oral Communications - Public:

5. HDL - Sales Tax & Measure S Update (3rd Quarter 2024)

Our first presentation was by David Mcpherson from HDL. He presented the 23rd quarter sales tax reports. He reviewed the quarterly newsletter which discussed the highlights for the City, including changes for both Sales Tax & Measure S Tax compared to prior years and the Top 25 Producers. He also discussed the changes to the previous year at the County & State levels. He also discussed trends, provided an agency comparison, and answered questions from commissioners.

6. Mid-Year 2025 Budget Amendments

Finance Director Rachel Jacobs presented the FY 2025 Mid-Year Budget Update. Director Jacobs reported that with the proposed budget changes to revenues and expenditures, the new projected surplus is \$381,063 for General Fund and \$1,977,329 for Measure S Fund. She answered questions regarding SEA transfers. Chairperson Jeff Lyle discussed wanting to see more comparative data in the future as it relates to prior year actuals, original budget, 1st budget updates and midyear updates.

7. Meeting Calendar Changes

Staff discussed changing the June & November meeting dates to align with Council meeting dates. The commission agreed, therefore, we are scheduling a special meeting on June 16th, canceling regular meeting on June 23rd, scheduling a special meeting on November 17th, and canceling regular meeting on November 24th.
