All submittals received before the start of the meeting will be made part of the record. Written submittals will be added to the record and not read out loud. Verbal comment participation: If you wish to provide a live verbal comment during the meeting, you attend the virtual meeting via your computer or call in.

Before Meeting:

- Public Participation Link:

- Join/Log-In to the meeting at least 15 minutes prior to the start time so that Staff can verify you are ready to speak before the meeting begins.

- If you call in as well for better audio, mute your computer's speakers to eliminate feedback so that you do not have two audios competing when you are speaking.
