ENCROACHMENT PERMIT APPLICATION INSTRUCTIONS

ANY CONSTRUCTION PERFORMED WITHIN THE CITY OF SOLANA BEACH PUBLIC RIGHT-OF-WAY AND EASEMENTS REQUIRES AN ENCROACHMENT PERMIT. IN ADDITION, ANY IMPROVEMENTS WHICH DO NOT CONFORM TO CITY STANDARDS MAY REQUIRE CITY COUNCIL APPROVAL.

Note: Encroachments for wireline communication facilities in the public right-of-way are subject to City of Solana Beach Policy No. 38 "Encroachment and Excavation Policies for Wireline Communication Facilities," as amended from time to time. Encroachment permits for wireline communication facilities expire 10 years from date of issuance, unless terminated earlier. Applicants for such encroachment permits must also follow the application instructions and review procedures specified in Policy No. 38, addition to the instructions below.

Please complete the following information on the Encroachment Permit neatly and completely:

- [1] Check type of work to be performed.
- [2] Address of the property where work will be performed.
- [3] Indicate who applicant is by checking the appropriate box.
- [4] Owner of the respective property and address of work.
- [5] Contractor's contact information if used. All construction within the public right-of-way or easement must be performed by a contractor who has a valid City of Solana Beach Business Certificate and a State of California Class A License (unless waived by the Engineering Department), with the exceptions listed below:
 - a) In lieu of a Class "A" License, a contractor performing sewer and/or water line work may possess a valid C-34, or C-42 State of California Contractors License.
 - b) In lieu of a Class "A" License, a contractor performing pavement work (i.e., curbs, gutters, sidewalk, driveways, etc.), may possess a valid C-8 or C-12 State of California Contractors License.
- [6] Engineer's or Other's contact information if applicable.
- [7] Complete section 8 if a contractor is used. The contractor must possess a current City of Solana Beach Business Certificate, and State License issued by the State Contractors Board.
- [8] Applicable if Owner/Builder and/or no person is employed in any manner so as to require compliance with the Workers' Compensation Law of California.
- [9] Describe the proposed type and amount of work. Attach plans if applicable.
- [10] Special Conditions of approval required by City (completed by Engineering staff).
- [11] Owner/Contractor Insurance information (completed by Engineering staff, if required).
- [12] Owner/Contractor may be required to sign this section if improvements will create a minor encroachment as determined by staff. Major encroachment of improvements will require a separate Encroachment Agreement and may require City Council approval.
- [13] As noted, a 48-hour advance notice is required for inspections. Contact Underground Service Alert for any excavations.
- [14] No trees within the City's right-of-way shall be planted, removed or relocated without prior approval from the Engineering Department. If work is near a City tree(s) or requires removal of a City tree(s), approval from the Engineering Department will be required. Any unauthorized City tree(s) removal and/or City tree damage may trigger a fine. If any City tree(s) are required to be removed to complete a project (i.e. City tree interfering with a proposed driveway approach), the City has the right to receive compensation for loss of property (i.e. value of lost tree).
- [15] If the work extends into the traffic lanes and/or impedes the normal flow traffic/pedestrians, a traffic control plan is required (to be determined by the Engineering Department).
- [16] Owner or authorized agent to read, sign and date.

Staff will determine the Encroachment permit fees and the permit fees must be paid prior to acceptance of the Encroachment Permit Application for review. A deposit equal to the Encroachment permit fee shall be due prior to commencement of the work. The deposit is refundable when the work is completed to the satisfaction of the Engineering staff and signed off as complete at Project Closeout.
