

CLIMATE & RESILIENCY COMMISSION MEETING REGULAR MEETING

1. CALL TO ORDER

Vice Chairperson Nagamine called the meeting to order 5:32 PM.

2. APPROVAL OF THE AGENDA

4. PUBLIC COMMENT

No public comment.

5. YOUTH V. OIL CAMPAIGN PRESENTATION — Youth V. Oil (Emma Weibel, Daryn Tarasewicz, Miles Wakeham and Elena Grilli) (Introduced by Commissioner Nagamine)

Public Speaker: Peter Zahn

Commissioner Dewar asked for an estimation of the dollar amount that would go into the super fund. This amount is determined by the EPA.

Commissioner Byars asked how this has played out in the states where it has been adopted. Youth v. Oil said that the New York and Vermont laws just recently went into effect, so they cannot speak to that yet.

Commissioner Rock asked which companies are included. Youth v. Oil said that California based companies who had CO2 emissions of 1 billion metric tons equivalent, from 1990 to 2024, would be required to pay into the superfund. These companies are involved in extraction, refining and processing of fossil fuels. Commissioner Rock asked what is the mechanism for receiving the money. Youth v. Oil answered that it is a fine on the company that is paid into the superfund.

Motion: Recommendation to take the California Polluters Pay Climate Superfund Act resolution before City Council. Moved by Buchannan. Seconded by Nagamine. Approved 7/0/2 (Absent: Flagg, Zito) **Motion Carried.**

6. ELECTRIC VEHICLE INFRASTRUCTURE DISCUSSION & RESOLUTION – Vice Commissioner Michelle Buchannan, Localized Energy Subcommittee

Public Speaker: Peter Zahn

Commissioners discussed EV infrastructure demands and implementation.

Motion: Recommend EV Charging Network Recommendations resolution to City Council. Moved by Gilliland. Seconded by Dewar. Approved 6/1/2 (Nays: Rock; Absent: Flagg, Zito) **Motion** Carried.

7. ELECTRIFICATION REBATES DISCUSSION & RESOLUTIONS – Localized Energy Subcommittee

Chairperson Sharman presented on the Electric Water Heater Contractor Incentive Program.

Public Speaker: Peter Zahn

Commissioners discussed the terms of the incentives.

Commissioner Byars asked if rebates are the best use of city funds. Commissioners discussed if the rebate effectively incentivizes something that may not be appropriate for the homeowner.

The City has a budget of \$100,000 for Climate Action Plan (CAP) implementation.

Motion: Chairperson Sharman called for a motion to take the Electric Water Heater Contractor Incentive Program resolution before City Council. Moved by Buchanan, seconded by Dewar. Denied 3/3/1/2 (Yeas: Buchanan, Heidi, Sharman; Nays: Byars, Gilliland, Nagamine; Abstain: Rock; Absent: Flagg, Zito).

Chairperson Sharman presented the Gas Water Heater Rebate Program.

Commissioner Gilliland shared what additional information she would need to understand the implications of the proposed resolutions and make an informed decision.

Dan King arrived at 7:02 pm.

Motion to delay the vote on the Gas Water Heater Rebate Program resolution to after the Workplan Presentation (Agenda Item 9). Moved by Buchanan. Seconded by Gilliland. Approved 7/0/2 **Motion carried.**

8. NATIVE POLLINATOR GARDEN AND PLANT LIST – Commissioner Heidi Dewar, Pollinator Friendly City Subcommittee

Motion to recommend list be forwarded to Staff and Council for inclusion in the City's landscape resources to the public. Moved by Buchanan. Seconded by Rock. Approved 7/0/2 **Motion carried.**

Vice Chairperson Buchanan presented the Native Pollinate Garden proposal.

Junior Commissioners leave at 7:19 pm.

Commissioners discussed how the pollinator garden fits with Chapter 4 of the CAP.

Motion to recommend plant list be forwarded to Staff and Council for inclusion in the City's landscape resources to the public. Moved by Buchanan. Seconded by Nagamine. Approved 7/0/2 **Motion carried.**

9. WORKPLAN PRESENTATION – City Staff

Ms. Grucky presented an overview of the City's Workplan Update.

Commissioners and Staff discuss ways to best utilize the CAP implementation budget.

Motion: Chairperson Sharman calls for a motion to take the Gas Water Heater Rebate Program resolution before City Council. Moved by Buchanan. Seconded by Sharman. Denied 2/5/0/2.
